I understand that **\$250.00** must be sent back with this contract as a non-refundable booking fee, which will be deducted when stud fee is paid. No mare will be bred until stud fee is paid in full. Breeding season will begin on February 1<sup>st</sup>.

Rafter BS Quarter Horses herein referred to as (RBS):

### **Mare owner agrees to the following (RBS) policies**

- ◆ \_\_\_\_\_ Mare owner agrees to attach a copy of registration papers to this contract.
- ◆ \_\_\_\_\_ Full breeding fee must be paid in advance before any mare will be bred and is non-refundable.

### **Rafter BS Quarter Horses and Mare Owner Mutually Agree**

- ◆ \_\_\_\_\_ Should the mare die before becoming in foal or become unfit for breeding, the mare owner may substitute a mare of his or her choice upon the approval of RBS, and must be in breeder's name. This applies to contract year and R/R year only.
- ◆ \_\_\_\_\_ In the event the mare is declared in foal and all fees are paid in full, if the mare dies or does not produce a live foal (a live foal being described by the industry as one that stands, nurses, and lives past one week of age), she will be bred the following season only. This guarantee will apply only if RBS is notified within forty-eight (48) hours from time of death. A statement from a licensed veterinarian must follow within two weeks.
- ◆ \_\_\_\_\_ A breeder's certificate will be issued for the foal, conceived by this mating, when stallion fee and all other expenses have been paid in full and, when mare has been pronounced safe in foal by a licensed veterinarian.
- ◆ \_\_\_\_\_ If mare fails to conceive in contract year, she has Right of Return option the following year only, subject to shipping and collection fees.

### **Transported Cooled Semen**

- ◆ \_\_\_\_\_ Contact Rafter BS Quarter Horses at (541) 786-2403 and/or Crestline Stables at (541) 519-9353 by 5:00 p.m. mst, 24 hours prior to needing semen. Collection days are Monday, Wednesday, and Friday. Cancellation must be done by 10:00 a.m. mst. Same day orders will be honored if time allows. Shipping fee will be required before shipment is made.
- ◆ \_\_\_\_\_ Full payment of stallion's stud fee, full payment of semen shipping (\$250) & collection fees (if applicable), copy of mare's registration papers and signed copy of semen contract must be received by the RBS office prior to semen shipment.
- ◆ \_\_\_\_\_ All shipments are done via Federal Express or UPS. Shipping costs may vary if weekend and/or holiday delivery necessitates alternate couriers or transcontinental flights.
